If swallowed Rinse mouth and then drink 200-300 ml of water. Never induce vomiting or give anything by mouth if the victim is unconscious or having convulsions.

Methods and materials for containment and cleaning up

Small Spills: Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal. Wipe up with absorbent material (e.g. cloth, fleece) clean surface thoroughly to remove residual contamination. Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal. Following product recovery, flush area with water.

Storage Requirements: Store in dry, well ventilated area. Keep containers tightly closed. Store between 50°F-80°F. Segregate from foods and animal feeds.
